Jean saw John Alexander Kay speak on the topic of Wildlife Photography at the Sherburne Refuge Photography Club meeting in May and asked if anyone was interested in hearing a good speaker on this topic. Everyone said yes to the idea of both speakers. Jean will follow-up on these two speakers. (Note: These two speakers, Matthew and John, are being put on hold pending further discussion among club officers and members.)

# Here's Jean's attempt at taking notes during Matthew's presentation on Drone Rules and Regulations:

#### Everyone:

- Can't fly higher than 400 feet
- Must remain in line of sight of drone or have a spotter
- Can't fly over people
- Contact airport to fly near it (within 5 miles)

- Can't fly under the influence
- Be aware of local laws and ordinances before flying over private property
- Allowed to fly in only some state parks
- Can't be flown in any National Parks or Refuges
- App called B4UFLY is best at telling you where it is allowed
- Can't fly over stadiums or sporting events during the event
- Must register UAV with FAA or you face stiff fines applies to drones weighing .55 lb to 55 lbs

# Commercial requirements:

- FAA part 107 commercial UAV test is required for commercial use test is \$150 to take
- Test has 60 questions out a possible list of many more questions
- Insurance is required and is specific to UAV can be \$2300 per year
- Must register with MNDOT and FAA if drone is .55 55 lbs
- Must do pre-flight checks to insure equipment is in good working order Before you fly
- Airspace Class G only

# Next Matthew went over a few details related to his DJI Inspire 2 drone:

- He was one of the first 400(?) in the country to get his.
- Shoots 4K video at 20 mp with X45 camera. This is the one he has.
- Shoots 5K video at 20 mp with X55 camera.
- Takes 21 mp photos.
- Has stabilization gimbal.
- Connected to Satellites to know exactly where it is.
- Can go up to 58 mph.
- It flies legally at 400 feet but it is capable of flying to 18,000 feet.
- Can go up to 4.5 miles away in distance but must be within line of sight or have spotter to be legal.
- Has 27 minutes flight time.
- Weighs 8 lbs.

Showed demos of work he has done using the drone. We then went outside to see it in action. Matthew took the following group photo using his drone and shared it with our club to use for our website and Facebook page.
